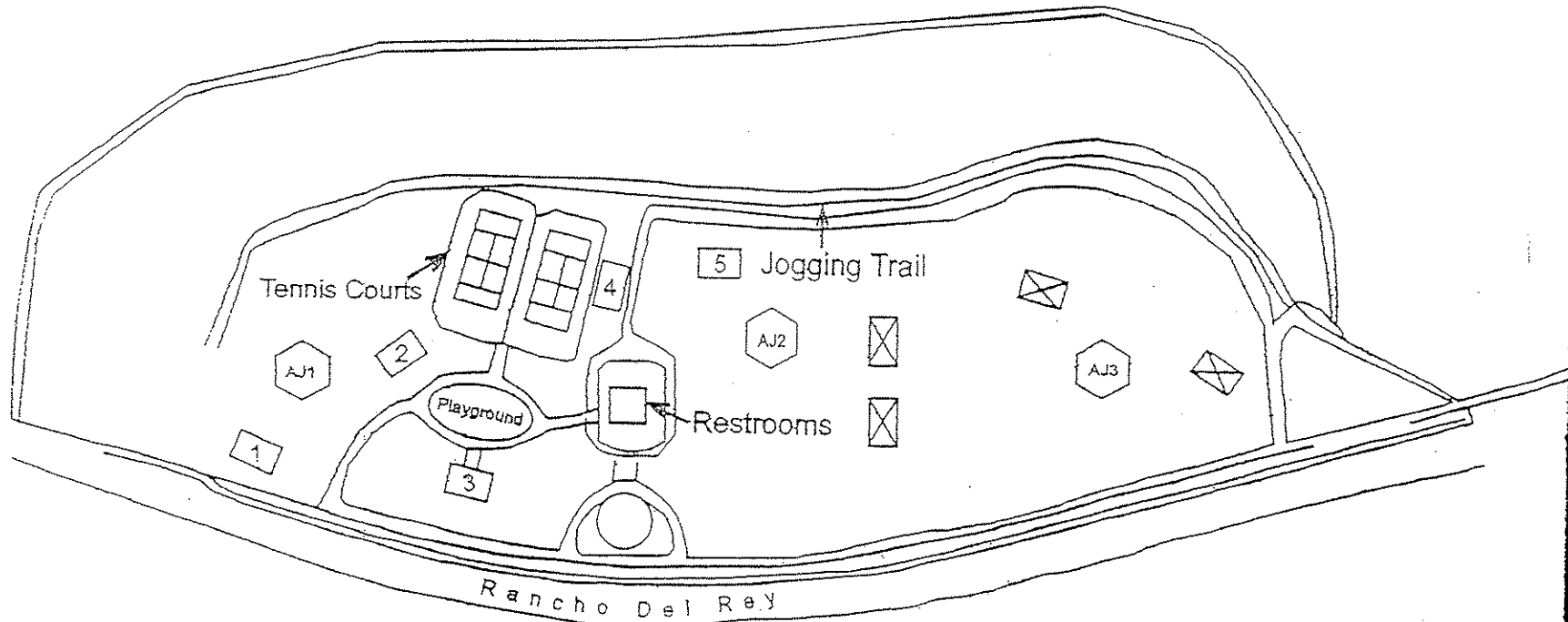


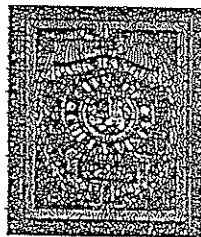

- START** 1: Start out going SOUTHWEST on MAXWELL RD toward DESIGN CT. 0.6 miles
-  2: Turn RIGHT onto MAIN ST. 0.5 miles
-  3: Stay STRAIGHT to go onto AUTO PARK DR. 0.3 miles
-  4: Merge onto I-805 N. 3.0 miles
-  5: Take the H STREET / BONITA RD exit toward E STREET. 0.1 miles
-  6: Take the H STREET ramp. 0.2 miles
-  7: Turn RIGHT onto E H ST. 1.1 miles
-  8: Turn LEFT onto DEL REY BLVD. 0.2 miles
-  9: Turn LEFT onto RANCHO DEL REY PKWY. 0.7 miles
- END** 10: End at 916 Rancho Del Rey Pkwy
