INSTRUCTIONS: The Mobilehome Stakeholder Committee is being formed in an effort to provide a recommendation to City Council on updates to the Mobilehome Closure Ordinance, Chula Vista Municipal Code Chapter 9.40 (CVMC 9.40). The stakeholder committee will be composed of 5 residents and 5 park owners with 2 additional alternates appointed from each group. This application is open to all current residents of mobilehome parks who own their coach/trailer and have an existing space rental lease. Selections will be made to ensure the committee is representative of the cross-section of parks within Chula Vista, including park type and geography. In addition, applicants should demonstrate their ability to communicate and disseminate information to the larger mobilehome community. Meetings of the stakeholders are anticipated to take place from January to March 2010.

Applicants will be short listed for potential stakeholders from each party. It is anticipated that interviews, if necessary, will be held December 1st through 8th, 2009 with final committee selection being made the week of December 14th.
