General Information

The Youth Basketball League will host practices in two geographic locations, East & West Chula Vista. Practices will begin the week of June 8th and may take place outdoors due to limited space. Practice schedules depend on the availability of the volunteer coaches and are held between 5-8pm, Monday-Friday, 1-2 days a week. Games will be played on Monday & Tuesday evenings and Saturdays all day. Each team will play two games per week (one weekday and one Saturday). Requests for children to be placed on the same team cannot be accommodated. Participants will not be placed on a team if they are not evaluated.


