We also agree to provide unlimited access to the fabrication areas, the materials storage and mixing areas, other related areas, the approved shop drawings and other documents for the purpose of inspection, sampling and testing by the special inspectors, construction materials testing laboratory or Planning and Building Department personnel during working hours. We further agree to provide an identifying mark on each fabricated member or component shipped to the to the construction site. A certificate of compliance and a shipping list shall accompany each shipment and a copy shall be sent to the Building Division Inspection Section and the architect
