All rights of any kind in and to all photographs and sound recordings made by film company on the premises shall remain vested in company, its successors and assigns, and the owner and/or lawful possessor of the premises shall not have the rights to said photographs or sound recordings.

Film company shall furnish the City with a certificate of insurance and policy endorsement page naming the City of Chula Vista as an additional insured.

This filming permit constitutes that where applicable, a film credit thanking the City of Chula Vista is required.

**CERTIFICATION**

I certify that to the best of my knowledge and belief the above statements are true and correct. On behalf of and as authorized by the film company, I certify that the company agrees to reimburse the City of Chula Vista for any loss or damage to the premises caused by this usage, and to defend, indemnify and hold harmless the City of Chula Vista (the City), its agents, elected and appointed officers and employees, from and against all claims for damages, liability cost and expense (including, without limitation, attorney’s fees), arising out of the conduct of any agent, officer, employee, subcontractor, or other person acting on behalf of the company, including ,but not limited to the actions of the participants, spectators and other attendees, in connection with the photoplay. Said indemnification shall include any and all costs, expenses, attorney’s fee and liability incurred by the City, its agent, officers, or employees in defending against such claims whether the same proceed to judgment or not. Further, film company, at its own expense, shall upon written request of the City, defend any such suit or action brought against the City, its agents, officers or employees. The company’s indemnification of the City shall not be limited by any prior or subsequent declaration by the said company.

The company further understands and acknowledges that this permission to film may be revoked for any violation of the rules and regulations upon the verbal notes of any responsible employee of the City of Chula Vista to the company or such responsible person present on behalf of the company.
